### **COURSE DESCRIPTION**

This 40-hour course was initially designed after a request from the Las Vegas Metropolitan Police Department. Its primary goal is to have the crime scene investigator become comfortable and proficient with discussing BPA theory as it relates to the scene investigation. The attendee will learn what elements compose the best photographs possible and apply it to scene analysis, and then incorporate them into a BPA report, knowing full well the findings could be discussed in court. They will create and construct demonstrative aids to assist in the testimonial before the court.

In order to meet this goal the following objectives will be made:

- A renewed BPA awareness of theories and terminology
- Correct photographic techniques
- Layout and design theory for a solid, court acceptable BPA report
- Practical elementary bloodstain pattern experimentation/creation (demonstrative aids)
- Creation of a demonstrative model of a spatter pattern to illustrate and explain 2D & 3D aspects
- Opportunities to speak publicly on theory before a group who know the theory

Each attendee will bring with them a PowerPoint presentation consisting of approximately 12 slides (or more) of a bloodletting scene they are knowledgeable on and present it to the class. Each attendee will have previously attended a 40 hour basic BPA course and have a minimum of 1 yr crime scene/BPA experience since that class.

### **INSTRUCTOR CRAIG C. MOORE**

- 16 years experience with the Forensic Services Unit of the Niagara Regional Police Service, Ontario Canada, where he retired in 2015 after 30 years of service.
- A certified Bloodstain Pattern Examiner with the IAI since 2000.
- Numerous published articles and in excess of 150 lectures presented.
- Testified and been accepted as an expert in Bloodstain Pattern Analysis at the General Division and Superior Court of Justice jurisdictional levels in Ontario, the County Court level in New York State and he was also called before a Board of Inquiry with the Canadian Armed Forces to offer expert opinion on a Bloodstain related shooting case.
- In 2006 the IAI recognized his efforts and awarded him the title, Distinguished Member
- Stepped down from IAI BPA committee after 12 years of continuous service since 2014
